Holding Belpharmprom is founded in 2017 to improve the management system for the pharmaceutical industry of the Republic of Belarus.

Holding Belpharmprom which is managed by the Pharmaceutical Holdings Company Belpharmprom includes 8 subsidiary companies: 6 pharmaceutical manufacturers, 1 scientific organization and 1 producer of medical devices. At the same time, 20 Belarusian companies and institutes of various forms of ownership and subordination, engaged in pharmaceutical and medical activities, cooperate with the holding on mutually beneficial terms.

About 7,000 highly qualified specialists work in the companies of holding Belpharmprom.

The share of companies of holding Belpharmprom in the total volume of exports of Belarusian medicines is more than 80%, and the share of holding Belpharmprom in the pharmaceutical production of the Republic of Belarus is more than 60%.

Currently, 47 production sites of the companies of holding Belpharmprom have national Good Manufacturing Practice (GMP) certificates, 4 sites are certified for compliance with GMP PIC/S standards and 5 sites are in the process of preparatory work for obtaining GMP certificates of the European Union, 35 sites are certified for compliance with the requirements of the Good Manufacturing Practice of the Eurasian Economic Union (EAEU).

At present pharmaceutical companies of holding Belpharmprom have about 800 types of medicines of various pharmacotherapeutic groups in their product portfolios. The companies' products of the holding are supplied to about 30 countries of the world.

The assortment portfolio of the enterprise is about 350 types of medicines and 36 synthesized pharmaceutical substances.

In recent years, Belmedpreparaty has undergone a complete technical re-equipment and the equipment of the world's leading suppliers has been installed.



In accordance with the approved standards and procedures, Belmedpreparaty ensures the quality of products at all stages of production, thus, the following activities are carried out:

- quality control of substances; – excipients;
- packaging materials; – finished products;
- study of the stability of drugs.

The effectiveness of work to maintain the quality of manufactured products of Belmedpreparaty is confirmed by certificates of compliance with GMP standards issued by the regulatory authorities of the Republic of Belarus, the Russian Federation, Ukraine and Romania.

Belmedpreparaty is an export-oriented company that supplies products to many countries of the world, including all CIS countries, Estonia, Vietnam, Syria, Afghanistan, Pakistan, Libya, Iraq, Mongolia, Kenya and Lebanon. The main export markets are the Russian Federation, Uzbekistan and Moldova. In the future, Belmedpreparaty will continue to develop new and promising markets in Southeast Asia, the Persian Gulf and Africa.

Following its main mission to take care of health and life of people the company produces a wide range of affordable and high-quality drugs. Every year Belmedpreparaty expands its product list, develops and introduces new drugs into production that are in demand in the domestic and foreign markets.

BORISOV PLANT OF MEDICAL PREPARATIONS OJSC



Today, "Borisov plant of medical preparations" OJSC has a good reason to boast of its status as the leader of pharmaceutical industry with more than half-century history in the Republic of Belarus. The professional activity of the three-thousand-strong company staff is aimed at the development and production of modern, effective and high-quality medicines. The mission of "Borisov plant of medical preparations»" OJSC is to protect, strengthen and restore people's health. Medicines manufactured by the company successfully compete both in domestic and foreign markets. High quality and efficiency of preparations manufactured by "Borisov plant of medical preparations" OJSC are known far beyond the borders of the Republic of Belarus.



More than 50% of the products are exported to foreign countries annually. Set up in 1965 the company initially specialized in manufacturing of liquid phytochemical, alcohol and oil drugs, ointments and gels. During the years of 2009–2011 large-scale modernization with the introduction of modern technologies for the medicines manufacturing process was implemented. Nowadays, the manufacturing facilities produce the annual output of 15 million tubes of ointments and gels, 16 million vials of tinctures and alcohol solutions for 49 names of the popular medicines.

The enterprise's mission is to provide consumers with effective and safe drugs affordable to all groups of population. Therefore, the enterprise disposes available modern facilities, accredited chemo-microbiological laboratory, and professional staff.

80 product designations are currently the drugs intended for cure of catarrhal diseases and influenza, gastrointestinal diseases, Vitamins and Vitamin-Mineral compounds, drugs for cardiovascular, nervous system and other disorders. More than one-third of medicines are on the "List of Basic Drugs" approved by the Ministry of Health of the Republic of Belarus.

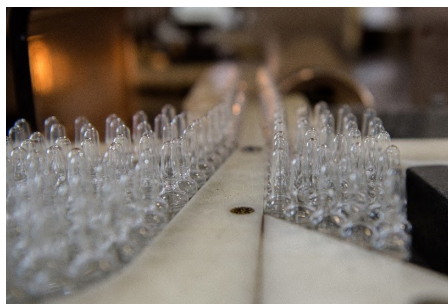
